What does the fund invest in?

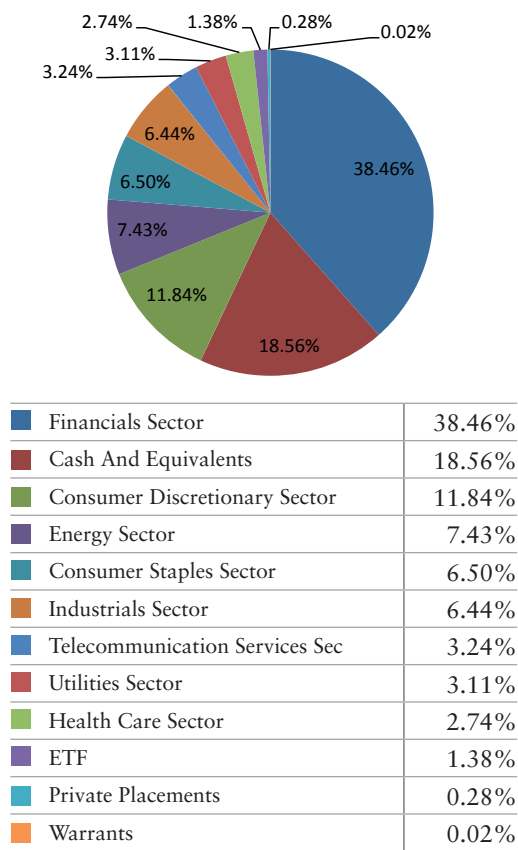
The Fund generates a high level of income and long-term capital growth by investing primarily in a mix of income-producing securities which may be located anywhere in the world. To achieve its objective, the fund intends to invest in units of Aston Hill High Income Fund.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Aston Hill Asset Management Inc. has rated the volatility of this fund as **medium**.

The rating is based on how much the fund’s returns have changed from year to year. It doesn’t tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

Like most mutual funds, this fund doesn’t have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how the Series F shares of the fund have performed over the past year. Returns are after expenses have been deducted. These expenses reduce the fund’s returns.

Year-by-year returns

This information is not available because the series has not been outstanding for a full calendar year.

Best and worst 3-month returns

Average return

Who is this fund for?

Investors who:

- are looking for a monthly income
- want to invest in income producing securities
- can handle the ups and downs of the stock market
- are looking for medium risk

! Don’t buy this fund if you need a high-risk, short-term investment.

A word about tax

In general, you’ll have to pay income tax on any money you make from the fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F shares of the fund. The fees and expenses—including any commissions—can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

No sales charges apply to Series F shares.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2015 the fund's expenses were 2.31% of its value. This equals \$23.10 for every \$1,000 invested.

	Annual rate (as % of the fund's value)
Management expense ratio (MER) This is the total of fund's management fee and operating expenses. Aston Hill Asset Management Inc. waived some of the fund's expenses. If it had not done so, the MER would have been higher.	1.34%
Trading expense ratio (TER) These are the fund's trading costs.	0.97%

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch shares of the fund.

Fee	What you pay
Advisory fee	You must participate in a fee-based arrangement with your dealer under which you pay an annual fee to your dealer that you negotiate with your dealer. The fee will be based on the value of your investments.
Short-term trading fee	2% of the value of shares you sell or switch within 30 days of buying them. This fee goes to the fund.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or fund facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, fund facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
