

### What does the fund invest in?

The fund invests primarily in a diversified portfolio of equity securities of North American issuers and, from time to time, will take short positions in such securities. The fund does not intend to follow the performance of the Toronto Stock Exchange.

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

Aston Hill Asset Management Inc. has rated the volatility of this fund as **medium**.

The rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

### No guarantees

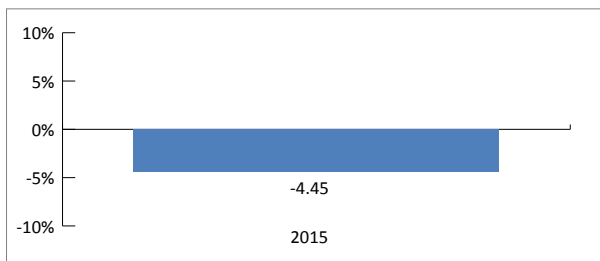
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

This section tells you how the Series UF units of the fund have performed over the past 1 year. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

#### Year-by-year returns

This chart shows how Series UF units of the fund have performed in the past 1 year. The fund dropped in value in 1 of 1 year. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for the Series UF units of the fund in a 3-month period over the past 1 year. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

A person who invested \$1,000 in the fund on May 15, 2014 would have had \$974.41 on March 23, 2016. This works out to an annual compound return of -1.38%.

### Who is this fund for?

Investors who:

- are looking for a long-term investment
  - want to invest in a diversified portfolio of equity securities of North American issuers that, from time to time, will take short positions in such securities
  - can handle the ups and downs of the stock market
  - Series UF units are intended for investors who want to invest in a fund in U.S. dollars and protect themselves from the impact of changes in the exchange rate between Canadian and U.S. dollars.
- ! Don't buy this fund if you need a low-risk, short-term investment.

### A word about tax

In general, you'll have to pay income tax on any money you make from the fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series UF units of the fund. The fees and expenses—including any commissions—can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

#### 1. Sales charges

No sales charges apply to Series UF.

#### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2015 the fund's expenses were 1.71% of its value. This equals \$17.10 for every \$1,000 invested.

<b>Management expense ratio (MER)</b> This is the total of fund's management fee and operating expenses. Aston Hill Asset Management Inc. waived some of the fund's expenses. If it had not done so, the MER would have been higher.	1.40%

#### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
Advisory fee	You must participate in a fee-based arrangement with your representative's firm under which you pay an annual fee to your representative's firm that you negotiate with your representative's firm. The fee will be based on the value of your investments.
Short-term trading fee	Up to 2.00% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or fund facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, fund facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
