

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

Aston Hill Asset Management Inc. has rated the volatility of this fund as **medium**.

The rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

### No guarantees

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

There is no historical performance because Series TA6 units have not been outstanding for a full year.

#### Year-by-year returns

### Who is this fund for?

### A word about tax

In general, you'll have to pay income tax on any money you make from the fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series TA6 units of the fund. The fees and expenses—including any commissions—can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You may have to pay a sales charge when you buy the fund.

Instead, you pay the deferred sales charge when the next investment is sold.</li> <li>Switching to a different series would require the payment of a reclassification fee.</li> <li>You generally can redeem up to 10% of your units each year without paying the deferred sales charge.</li> </ul>

### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

The fund's expenses are made up of the management fee, operating expenses and trading costs. The Series TA6 annual management fee is 2.00% of the fund's Series TA6 value. Because this series is new, its operating expenses and trading costs are not yet available.

#### More about the trailing commission

Aston Hill Asset Management Inc. pays your representative's firm a trailing commission for as long as you own the fund. The trailing commission is an ongoing commission. It is for the services and advice your representative and their firm provide to you. The trailing commission is paid out of the management fee and is based on the value of your investment. The rate depends on the sales charge option you choose:

- Initial sales charge – up to 0.50% of the value of your investment. This equals \$5 for every \$1,000 invested.
- Low-load deferred sales charge – up to 5% of the value of your investment for the first three years (1.00% after three years). This equals \$50 for each of the first three years (and \$10 each year after three years) for \$1,000 invested.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
Short-term trading fee	2.00% of the value of units you sell or switch within 30 days of buying them. This fee goes to the fund.
Switch fee	Your representative's firm may charge up to 2.00% of the value of units you switch to another Aston Hill Mutual Fund.
Reclassification fee	When you switch to a different series, Aston Hill Asset Management Inc. will charge you a reclassification fee equal to the amount of the Low-Load Deferred Sales Charge you would have paid had you instead redeemed the Series TA6 units.

#### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or fund facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, fund facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
