ASTON HILL FINANCIAL INC. ANNOUNCES THE LAUNCH OF NEW CORPORATE CLASS FUNDS ALONG WITH NEW MONEY MARKET FUND, AND THE REBRANDING OF THE RECENTLY ACQUIRED BROMPTON FUNDS

Toronto, ON – September 12, 2011: Aston Hill Financial Inc. (“Aston Hill”) today announced that it has successfully launched new corporate class versions of its existing mutual funds, along with a new money market fund. In addition, Aston Hill announced that it has changed the names of the recently acquired Brompton closed-end funds, in each case replacing “Brompton” with “Aston Hill”. New Funds

The launch of the new corporate class funds and the new money market fund is another key step in positioning Aston Hill as a go-to brand for its investors and financial advisors. This new launch comes on the heels of the successful conversion of Aston Hill Capital Growth Fund and Aston Hill Global Convertible Bond Fund (each formerly closed-end funds) to mutual funds.
